- A. Arrive in weather appropriate attire, including close toed shoes, and be prepared for varying weather.
- B. Arrive 10-15 minutes prior to shift start to sign in at the Volunteer Headquarters. I will also sign out at volunteer headquarters at the end of my shift. If I fail to do so, my hours may not be counted in any raffle drawings.
- C. Wear the Blues Brews and BBQ Festival shirt given to me at sign in for the duration of my shift. If I work more than one shift, I must wear the shirt given to me at the beginning of my first shift.
- D. Arrive sober and free of drugs and remain so for the duration of my shift(s).
- E. Will not carry weapons or illegal paraphernalia on my person or in my personal belongings while on festival grounds.
- F. Will be at least 16 years of age on or before June 15, 2014.
- G. Will NOT be entitled to compensation or other benefits from Fluid Events, nor am I entitled to workman’s compensation claims as I am a volunteer.
- H. Understand that Cell Phones and other personal electronics are to be used for emergency purposes only while I am working a shift. Also that Fluid Events will not be held liable for any loss or damage to these devices or personal property that I bring.
- I. Never leave my station without the permission of the person supervising me.
- J. Understand that Parking and/or transportation to/from the event is my own responsibility.
- K. Fluid Events Management reserves the right to dismiss me from the festival at any time for any reason, including non-compliance with the terms of this agreement.
